Prospective purchaser(s) are advised to refer to the sales brochure for the phase of the development for information on the phase of the development.
- (2) 根據《一手住宅物業銷售條例》第 52(1)條及第 53(2)及(3)條， –  
According to sections 52(1) and 53(2) and (3) of the Residential Properties (First-hand Sales) Ordinance, –
- 第 52(1)條 / Section 52(1)  
在某人就指明住宅物業與擁有人訂立臨時買賣合約時，該人須向擁有人支付售價的 5%的臨時訂金。  
A preliminary deposit of 5% of the purchase price is payable by a person to the owner on entering into a preliminary agreement for sale and purchase in respect of the specified residential property with the owner.
- 第 53(2)條 / Section 53(2)

If a person executes an agreement for sale and purchase in respect of the residential property within 5 working days after the date on which the person enters into the preliminary agreement for sale and purchase, the owner must execute the agreement for sale and purchase within 8 working days after that date.
- 第 53(3)條 / Section 53(3)

The purchaser(s) shall by prescribed form apply to the Designated Lender for second mortgage loan, not less than 60 days before the due date of payment of the balance of the transaction price.

The interest rate of the first 36 months of the second mortgage loan shall be at a fixed rate of 3.5% p.a.. P is subject to fluctuation. The final mortgage rate will be subject to final approval by the Designated Lender. No representation, undertaking or warranty, whether express or implied, is given, or shall be deemed to have been given by vendor in respect thereof.
