The method to be used to determine the order of priority in which each of the persons interested in purchasing any of the specified residential properties may select the residential property that the person wishes to purchase:

將會使用何種方法，決定有意購買該等指明住宅物業的每名人士可揀選其意欲購買的住宅物業的優先次序：

1. General provisions:

一般規定：

1.1. Where more than one specified residential property is covered in one preliminary agreement for sale and purchase, the purchaser of each of such residential property shall comprise the same person or the same group of persons.

如同一份臨時買賣合約包括多於一個住宅物業，每一該等指明住宅物業之買方須由同一人士或同一組人士構成。

1.2. In case of any dispute, the Vendor reserves its absolute right to allocate any specified residential properties to any interested person.

如有任何爭議，賣方保留自行分配任何指明住宅物業予任何有意欲購買的人士之最終決定權。

2. Balloting will be used to determine the order of priority for selection of specified residential properties on the First Date of Sale. On the First Date of Sale and thereafter, there will be a Public Sale. Details are as follows.

於出售首日，揀選指明住宅物業的優先次序將以抽籤方式決定。出售首日及之後將進行公開認購。詳情請參看下文內容。

3. To participate in the balloting, interested persons must first submit a registration of intent (“**Registration of Intent**”). Interested persons may call 2880 8268 (Hotline for the Phase of the Development (“**Phase**”)) for details of obtaining the form of Registration of Intent, which said form is also available for collection on the 20th Floor of the Designated Venue. The manner for the submission of a Registration of Intent and the documents and materials required, etc. are specified in such form of Registration of Intent. Please refer to such form of the Registration of Intent for details. Amongst the same group of Registrations of Intent, the order of the submission of a Registration of Intent will not have any impact on the order of priority for selecting the specified residential properties. In general:

- 3.1 Based on the selection made under the Registration(s) of Intent by the registrant(s) (“**Registrant(s)**”), each Registration of Intent may be used for showing of interest to purchase either:-

- (i) 1 specified residential property in the Phase (the Registration of Intent of this type is referred to as “**Group B Registration of Intent**”)(for the avoidance of doubt, a company Registrant can only purchase 1 specified residential property and its Registration of Intent shall be classified as a Group B Registration of Intent); or
- (ii) 2 or more specified residential properties in the Phase (the Registration of Intent of this type is referred to as “**Group A Registration of Intent**”)

Provided That:-

- (a) each individual Registrant submitting a Group A Registration of Intent shall purchase not less than 2 specified residential properties in the Phase by using such Group A Registration of Intent submitted, purchasing less than 2 specified residential properties under a Group A Registration of Intent will render such Group A Registration of Intent void and disqualified;
- (b) each individual Registrant submitting a Group B Registration of Intent shall only purchase not more than 1 specified residential property in the Phase by using the Group B Registration of Intent submitted and each individual Registrant submitting 2 Group B Registrations of Intent may only purchase not more than 2 specified residential properties in the Phase by using 2 Registrations of Intent submitted; and
- (c) each company Registrant may only purchase 1 specified residential property in the Phase by using the Group B Registration of Intent submitted.

按照登記人(「**登記人**」)於購樓意向登記中所作出的選擇，每張「**購樓意向登記**」可用以下其中一種方式表達有意認購:-

- (i) 1個期數中的指明住宅物業(此等購樓意向登記下稱為「**B組購樓意向登記**」)(為免疑問，公司登記人只可認購1個指明住宅物業而其購樓意向登記將被歸類為**B組購樓意向登記**); 或
- (ii) 2個或以上期數中的指明住宅物業(此等購樓意向登記下稱為「**A組購樓意向登記**」)，

In addition to copies of specified identification documents, appropriate number of cashiers' order(s) must be submitted together with a Registration of Intent. Detailed arrangements are as follows:-.

Each Group A Registration of Intent shall be submitted together with 2 cashiers' orders, each in the sum of HK\$100,000 made payable to "Deacons". If a Registrant submits 2 Group A Registrations of Intent, 4 cashiers' orders as aforesaid shall be submitted. Should the Registrant eventually purchase more than 4 specified residential properties in the Phase, the Registrant shall submit the extra cashiers' order(s) drawn in the above manner to the intent that 1 cashiers' order shall be made available for part payment of preliminary deposit of each of the specified residential properties so purchased by the Registrant. If a Registrant submits 2 Group B Registrations of Intent, 2 cashiers' orders as aforesaid shall be submitted. - 3.2 Notwithstanding anything as may be specified in the Registration of Intent, a completed Registration of Intent shall be submitted to the 20th Floor of the Designated Venue on or before 17 March 2016 during the following opening hours: 2:00 p.m. to 9:00 p.m. from Monday to Friday (except to 10:00 p.m. on the last submission date, 17 March 2016) or 11:00 a.m. to 9:00 p.m. on a Saturday, Sunday or public holiday.

即使購樓意向登記內可能指定任何其他安排，填妥之購樓意向登記須於2016年3月17日當日或之前於下述開放時間，即下午2時至晚上9時（星期一至五）（惟於遞交的限期日，即2016年3月17日，則至下午10時）或上午11時至晚上9時（星期六、星期日或公眾假期），遞交至指定會場的20樓。

- 3.3 Each individual registrant can submit a maximum of 2 Registrations of Intent and each corporate registrant can submit only 1 Registration of Intent. For Registrant comprising 2 or more individual registrants under a Registration of Intent, each of such individual registrants shall be regarded as having submitted a Registration of Intent. (e.g. if individual registrant (A) submits 2 Registration of Intent one in his own name and the other one in the joint names of himself and individual registrant (B), then individual registrant (B) may submit only 1 more Registration of Intent, either in his own name or in

joint names with others (other than individual registrant (A)).

- 3.4 Higher priority of selection of specified residential properties will be given to Group A Registrations of Intent in accordance with the provisions in paragraph 4 below. Balloting will be used to determine the order of priority amongst Group A Registrations of Intent as a separate group. Balloting will be used to determine the order of priority of Group B Registrations of Intent as another separate group in a lower priority than Group A Registrations of Intent.

I. First round balloting (for dividing all Registrants into different groups)

第一輪抽籤（將所有登記人分為不同組別）

- (i) The first round balloting will take place on the day before the First Date of Sale at or after 12:00 noon at 19th Floor of the Designated Venue for the purposes of dividing the Group A Registrations of Intent and Group B Registrations of Intent into different groups. The Vendor reserves the right at any time, for the purposes of maintaining order and/or facilitating smooth sale of the specified residential properties, to adjust the time and date of the first round balloting. Any changes to the time and date of the first round balloting will be posted on the 20th Floor of the Designated Venue and announced on the website of the Phase (“**Project Website**”). Registrants will not be notified separately of such changes.
第一輪抽籤程序將於出售首日前一日中午12時或於該時間之後於指定會場的19樓進行，以將A組購樓意向登記及B組購樓意向登記分為不同組別。為了維持秩序及流暢地銷售指明住宅物業，賣方保留權利在任何時間調整第一輪抽籤程序的時間和日期。任何第一輪抽籤程序的時間和日期的修改會於指定會場的20樓展示及於期數的網站（「項目網站」）內公布。登記人將不獲另行通知該等修改。

(as the case may be) which will take place in batches on the First Date of Sale, the groups belonging to Group A Registrations of Intent shall have priority over the groups belonging to Group B Registrations of Intent. The groups belonging to Group B Registrations of Intent shall follow thereafter.

II. Second round balloting (for determining the order of priority of Registrants in selecting and purchasing specified residential properties)

- (i) The second round balloting of different groups of Registrants of Group A Registrations of Intent or Group B Registration of Intent (as the case may be) will take place on the First Date of Sale in batches at the Designated Venue at such time(s) as posted and announced by the Vendor pursuant to paragraph 4.I(iv) above. The Vendor reserves the right at any time, for the purposes of maintaining order and/or facilitating smooth sale of the specified residential properties, to adjust the time and date of the second round balloting. Any changes to the time and date of the second round balloting will be posted on the 20th Floor of the Designated Venue and announced on the Project Website. Registrants will not be notified separately of such changes.

第二輪抽籤程序將於出售首日於賣方根據上述第4.I(iv)段展示及公布之時間依A組購樓意向登記或B組購樓意向登記(視乎情況)所屬的不同登記人組別於指定會場分階段進行。為了維持會場秩序及／或流暢地銷售指明住宅物業，賣方保留權利在任何時間調整第二輪抽籤程序的時間和日期。任何抽籤程序的時間和日期的修改會於指定會場的20樓展示及於項目網站內公布。登記人將不獲另行通知該等修改。

Card(s)/Passport(s) and (if applicable) copy of Business Registration Certificate and documents filed with the Companies Registry showing the current list of director(s) and secretary and the original receipt of the valid Registration of Intent for registration. Registrants who arrive at the Designated Venue beyond their applicable Attendance Registration Periods shall not be eligible to participate in the second round balloting.

The groups belonging to Group B Registrations of Intent shall follow thereafter.

5. The following provisions apply to the First Date of Sale:

- (a) If Registrant(s) of a Group A Registration of Intent, for whatever reasons, select(s) less than 2 specified residential properties, or if Registrant(s) of a Group B Registration of Intent is, for whatever reasons, unable to select 1 specified residential property, the relevant Registration of Intent shall become void and shall be disqualified and such Registrant will cease to be eligible to select any specified residential properties in respect of that Registration of Intent.

如一份A組購樓意向登記的登記人因任何原因揀選少於2個指明住宅物業，或如一

份B組購樓意向登記的登記人因任何原因未能揀選到1個指明住宅物業，該份購樓意向登記將會失效並被廢除資格，而該登記人將沒有資格就該購樓意向登記揀選任何指明住宅物業。

- (b) The cashiers' order submitted with the Registration of Intent will be encashed to settle part of the preliminary deposit of each of the specified residential properties purchased (the balance of which shall be paid by cheque(s) and/or cashiers' order(s)) if the Registrant shall successfully purchase a specified residential property. Should a Registrant of a Group A Registration of Intent eventually purchase more than 2 specified residential properties in the Phase under a Group A Registration of Intent, the Registrant shall submit the extra cashiers' order(s) drawn in the above manner to the intent that 1 cashiers' order shall be made available for part payment of preliminary deposit of 1 specified residential property so purchased by the Registrant.

登記人每成功購入一個指明住宅物業，隨購樓意向登記附上的銀行本票將被兌現以支付所購入的指明住宅物業的部份臨時訂金（臨時訂金餘款以支票及/或銀行本票支付）。如一份A組購樓意向登記之登記人最終購買多於2個期數中的指明住宅物業，登記人須遞交根據上述方法開出的額外本票以達至就每1個所購買的指明住宅物業出具1張本票用以支付該指明住宅物的部份臨時訂金的要求。

- (c) Where Registrant(s) of a Group B Registration of Intent select(s) any specified residential property, the purchaser(s) of that specified residential property shall be the Registrant(s) named in such Group B Registration of Intent subject to the right of such Registrant to add in any immediate family member(s) as purchaser(s), according to sub-paragraph (e) below.

當一份B組購樓意向登記的登記人揀選任何指明住宅物業，只有於該B組購樓意向登記中訂明的登記人才可成為該指明住宅物業的買方，但該登記人有權按下文分段(e)加入家人作為買方。

- (d) If two or more Registrants are named in a Group A Registration of Intent, then in so far as the Registrants are the immediate family members of each other, when such Registrants select specified residential properties, the specified residential properties selected under the relevant Group A Registration of Intent may be purchased in the joint names of such Registrants or in their respective own names as purchaser(s) provided that each of such Registrants shall have been named in a preliminary agreement for sale and purchase ("PASP") of 1 specified residential property so purchased. The right of adding family members under paragraph (e) below shall apply only to the Registrant(s) named as purchaser(s) in the relevant PASP.

For the avoidance of doubt: (i) only specified residential properties available for selecting may be selected; and (ii) the purchaser(s) of any additionally selected specified residential property(ies) shall be the Registrant of the relevant Qualified Registration of Intent, subject to paragraph 5(e) above.
