In case of any dispute, the Vendor reserves its absolute right to allocate the above residential property(ies) to any person interested in purchasing by any method (including balloting).

In order to maintain order at the sales office and to ensure the smoothness of the selection procedures, after Prospective Purchasers have selected a specified residential property, the Prospective Purchasers will be requested to proceed with the signing of preliminary agreement for sale and purchase of that specified residential property.
